NOTE: Meetings are held every second Tuesday of each Month: 7 to 9pm.



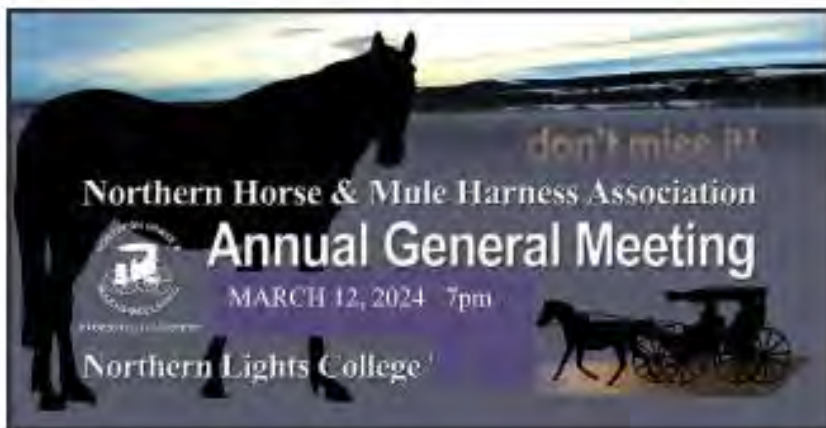
